TERMS & CONDITIONS FOR ORDER PLACEMENT

PAYMENT TERMS. U.S. ACCOUNTS: On approved credit, Buyer shall pay The Jewelry Group Inc. (“TJG”) for all goods shipped to Account within thirty (30) days of shipment (Net30 from date of invoice). In the absence of approved credit, all goods shall be paid in cash, company check, wire transfer, or major credit cards in advance prior to shipment unless the Buyer and TJG expressly agree otherwise in writing. All references to money amounts herein, unless otherwise specified, shall be in United States currency. Remit Payments to: Premier Brands Group, The Jewelry Group Inc., PO Box 277512, Atlanta, GA 30384-7512 US. Please include your TJG Customer Number and Invoice Number on the check. A charge of Thirty-Five Dollars (\$35) will apply to all returned checks.

INTERNATIONAL ACCOUNTS: A Thirty-Five Dollar (\$35) bank fee will apply for each wire transfer.

FREIGHT TERMS: F.O.B. TJG (Shipping point).

Please note: You may request to be contacted when your shipment is ready for final credit card authorization. Freight charges may not be available at the time of authorization. Please make advance notification requests in writing when your initial order is placed.

TITLE: Title passes to Buyer at TJG’s dock. TJG’s responsibility is limited to proof of delivery to carrier.

BACK ORDERS: Unless notified otherwise, TJG reserves the right to back order and/or split ship on a purchase order if necessary.

INITIAL ORDER MINIMUM: A Five Hundred Dollars (\$500) opening order is required to be set up as a new TJG account.

RE-ORDER MINIMUM: The minimum re-order amount is Two Hundred Dollars (\$200).

SHIPMENT REFUALS: We will charge a Twenty Percent (20%) re-stocking fee for all refused shipments.

SHIPMENT DISCREPANCIES OR DAMAGES: All claims for shortages, shipping discrepancies (style/color/size/overages, etc.) and/or damages must be received in writing within five (5) business days of order receipt or remittance invoice(s).
