## Terms & Conditions for Order Placement

---

**PAYMENT TERMS (U.S. ACCOUNTS):** On approved credit, Buyer shall pay **Mundi Westport** for all goods shipped to Account within thirty (30) days of shipment (Net 30 days from date of invoice). In the absence of approved credit, all goods shall be paid in cash, company check, wire transfer, or major credit cards in advance prior to shipment unless the Buyer and **Mundi Westport** expressly agree otherwise in writing. All references to money amounts herein, unless otherwise specified, shall be in United States currency. Remit payments to **Mundi Westport Group**, P.O. Box 2002, Pine Brook, NJ 07058. Please include your Customer Number and Invoice Number on the check. A charge of \$35 will apply to all returned checks.

**CREDIT CARD:** Beginning March 1, 2024, a 3.0% convenience fee will apply on all credit card transactions.

**INTERNATIONAL ACCOUNTS:** A \$35 bank fee will apply for each wire transfer.

**FREIGHT TERMS:** F.O.B. **Mundi Westport** (Shipping Point).

Please note: You may request to be contacted when your shipment is ready for final credit card authorization. Freight charges may not be available at the time of authorization. Please make advance notification requests in writing when your initial order is placed.

**TITLE:** Title passes to buyer at **Mundi Westport's** dock. **Mundi Westport's** responsibility is limited to proof of delivery to carrier.

**BACK ORDERS:** Unless notified otherwise, **Mundi Westport** reserves the right to back order and/or split ship on a purchase order if necessary.

**INITIAL ORDER MINIMUM:** A \$500 opening order is required to be set up as a new **Mundi Westport** account.

**RE-ORDER MINIMUM:** The minimum re-order amount is \$300.

**SHIPMENT REFUSALS:** We will charge a 20% re-stocking fee for all refused shipments.

**SHIPMENT DISCREPANCIES OR DAMAGES:** All claims for shortages, shipping discrepancies (style/color/size/overages, etc...) and/or damages must be received in writing within 5 working days of order receipt or remittance invoice (s). **Mundi Westport** will issue credit only when claims are accompanied and supported by documentation that verifies such claims. Email [arremit@mundiwestport.com](mailto:arremit@mundiwestport.com) your claim. Please provide us with the order details along with your Customer Number or Invoice Number.

**RETURNS:** Returns cannot be made without a return authorization number (RA) provided by **Mundi Westport**. All return requests on defective product are processed through our Returns Department.

Please note: **Mundi Westport** will not participate in the practice of accepting chargebacks for Handling, Administrative Fees, Service Fees or Penalties for PO Violations or Shipping Errors.

**WARRANTY:** We warrant that our products are free from material and sewing defects for up to 6 months from customer purchase date. We will not cover product that has been submerged in water, worn out, or abused either by misuse or extreme element exposure. Should warranty replacement or credit for merchandise be required, picture of the damaged article that can be seen clearly must be submitted along with copy of customer receipt. Email claim to [harleysales@mundiwestport.com](mailto:harleysales@mundiwestport.com). If the product is available, we will replace or credit, dealership's choice. If the product is not available, a credit will be issued. If product is approved for replacement, a UPS label will be emailed for return of the defective merchandise to Mundi Westport. Upon receipt, a new product will be shipped out.

**INTERNATIONAL WARRANTY:** Credit will be issued on approved resolution.

**CANCELLATIONS:** Order cancellations will be at the discretion of **Mundi Westport**. Any goods in transit at time of receipt of cancellation notice must be accepted by Buyer. We require at least a two-week shipping window based on start ship and stop ship date. We do not recognize "Received by" or "In House By" dates.
